B. Purpose and Scope of Contract and Health Guarantee (CHG)

I. This is a legal and binding contract entered into by Kammi Kai Hefner and Kimma B. Hefner (Breeder), herein after known as the Breeder, and _____ (New Owner), herein after known as the New Owner. Failure to comply with this contract could result in litigation between the Breeder and the New Owner in the Breeder's state and county.

II. The purpose of this BREEDER & NEW OWNER CONTRACT AND HEALTH GUARANTEE FOR PET QUALITY PUPPY/DOG is to describe to the New Owner safeguards and guarantees he can expect from an ethical breeder, demonstrate the integrity of the Breeder, and protect the interests of both the Breeder and the New Owner and, to describe the responsibilities of the New Owner.

C. General Agreement Terms

I. Inasmuch as the New Owner wishes to acquire the Rhodesian Ridgeback for the sum of \$_____, and \$ 50.00 for microchipping under the following warranties and conditions with no other warranties or breeding conditions either expressed or implied thereafter. No ownership part of said animal may be transferred to a third party without prior approval and written consent from the Breeder.

II. Payment Plan. A \$_____.00 non-refundable deposit will be applied toward the agreed upon purchase price. Balance is due upon receipt of said animal.

III. Breeder guarantees that the above described puppy/dog is a purebred Rhodesian Ridgeback, registerable with the American Kennel Club (AKC), and that the appropriate registration papers will be given to the New Owner upon completion of requirements stipulated in Section **XXVIX**. A true copy of said animal's pedigree has been provided at <http://www.wendelboe.com/pedigree.html> and a copy is contained in said animal's Kushinda Puppy/Dog Packet.

IV. The Breeder represents the Rhodesian Ridgeback described herein as **PET** quality, being sold on a Pet Contract (spay/neuter is required). This animal is NOT considered to be of show or breeding quality, but is a representative of its breed and structurally and temperamentally suited as a companion and/or obedience dog. New Owner agrees to have said animal neutered/spayed after the age of thirty months. **New Owner agrees to contact Kushinda before scheduling the spay/neuter appointment. Contacting Kushinda may be accomplished via email, telephone, or letter.** New Owner agrees to send a copy of the neuter/spay surgery to the Breeder within three weeks after said surgery. New Owner understands that this a requirement in order to receive AKC Registration papers for said animal. *This agreement is in compliance with the Dog Purchaser Protection Act as stipulated in Section (f) 3. 3. 3. [See Appendix A].* **This is a specific requirement in order to receive said animal's registration papers.**

V. This animal has been thoroughly examined by the Breeder and is found to be in good health at this date. All required inoculations (i.e., Parvo, DHPP) and other preventative care (i.e. wormings) for the animal **required to date**, have been attended to by the Breeder (see animal's Medical Record for exact measures).

New Owner agrees to establish a booster vaccination program and heartworm preventative program with their veterinarian on their first visit.

New Owner agrees to ensure that said animal is **NOT GIVEN a LEPTOSPIROUS shot** until said animal is one (1) year of age or older; unless it is determined by your Veterinarian you are in an area where it is necessary at this early age.

New Owner agrees they have received a copy of said animal's Health Certificate issued by a veterinarian within twenty-one days prior to the date of sale for the puppy/dog or a guarantee of good health issued and signed by the Breeder. In addition, New Owner agrees they have received a copy of said animal's Health Records at the time of sale.

At all times throughout the puppy/dog's lifetime, the New Owner agrees to ensure that said animal is **NOT GIVEN** more than one of the following vaccinations per vet visit:

- 1) Canine Distemper-Adenovirus Type 2 - Parainfluenza-Parvovirus Canine Coronavirus Vaccine (before one year of age) **or**
Canine Distemper-Adenovirus Type 2 - Parainfluenza-Parvovirus Canine Coronavirus Vaccine Leptospirosis (after one year of age);
- 2) Rabies;
- 3) Bordatella;
- 4) Lymes;
- 5) Giardia.

Should said animal be determined to be in ill health, the cause of which is clearly attributable to the Breeder, the New Owner, upon presentation of written diagnosis from said veterinarian, may elect to return said animal to the Breeder along with all accompanying registration (signed back to the Breeder), pedigree, and information papers for refund of purchase price. New Owner agrees to provide transportation of said animal to return to the Breeder.

VIX. The Breeder represents the Rhodesian Ridgeback described herein as **PET** quality therefore, no guarantees are offered or expressed or implied after said 10-day period. Breeder does guarantee that all medical precautions have been taken to avoid genetic health problems.

X. New Owner shall assume full responsibility for the health, anatomical make-up, appearance and temperament of said animal upon date of purchase. All kenneling and maintenance expenses will be borne by the New Owner. This includes boarding fees, food, veterinary fees, medication, and transportation fees.

XI. Breeder is willing to give advice to the New Owner in any matter concerning the well being of said animal for the entire life of said animal.

XII. New Owner agrees to take proper safeguards for the care and safety of the Rhodesian Ridgeback sold herein including but not limited to necessary food, veterinarian care, and general care to maintain good and proper health, proper shelter, and adequate exercise (Breeder recommends that said animal should be provided the opportunity to relieve himself every four hours, as a minimum). New Owner agrees to read all written materials supplied with said animal and to become knowledgeable on raising said animal.

XIII. New Owner may never train or use the Rhodesian Ridgeback described herein for fighting or attack purposes.

XIV. **New Owner agrees that if at any time they are unable to keep said animal due to a change in their circumstances and are forced to seek another “new” owner for said animal**

XVI. New Owner agrees to notify the Breeder in writing within two months after the completion date of any certified agility, conformation, obedience, field (lure coursing), therapy, tracking or other titles earned by said animal.

XVII. Breeder and New Owner agree to establish some form of communication concerning said animal's well being and overall adjustment to life as a Rhodesian Ridgeback on an annual basis. Breeder requests change of address or telephone notification from the New Owner.

XVIII. New Owner agrees to notify the Breeder in writing in the event of an untimely death of said animal.

XIX. Obligations of the Breeder set forth in this agreement will cease under the following conditions: A. Traumatic injury to said animal, or B. Abuse and/or neglect of said animal, and/or C. Death of said animal.

XX. It is stipulated by and between the parties that failure to comply with the conditions of this BREEDER & NEW OWNER CONTRACT AND HEALTH GUARANTEE FOR PET QUALITY PUPPY/DOG will result in the said animal being returned permanently to the Breeder, at the New Owner's expense. Any legal fees resulting from this purchase will be solely borne by the New Owner.

XXI. Breeder and New Owner understand and agree to all terms and conditions of this contract, and therefore sign in agreement thereto. This Sale Contract Agreement shall be governed by the laws of the state of West Virginia and Pennsylvania to the exclusion of any other forum and constitutes the entire agreement between the parties. New Owner agrees not to question the face value of intended statements contain within this contract. New Owner agrees that the Breeder has final say on all interpretations of intended statements.

XXII. New Owner understands that the Breeder requires attending one Puppy Kindergarten classes and one Basic Home Obedience classes. New Owner understands that the Breeder requires obtaining the America Kennel Club's Canine Good Citizenship certificate **These are specific requirements in order to receive said animal's registration papers.**

XXIII. New Owner understands that the Breeder recommends keeping said Rhodesian Ridgeback "lean" in weight throughout their life. New Owner agrees to provide annual updates in January on said animal's physical stature: height measured in inches at the withers and weight in pounds (as weighed using a weight scale).

XXIV. New Owner understands that the Breeder encourages participation in Lure Coursing.
